As the contact person, I agree to abide by the rules and regulations as established by the Ordinances pertaining to the CBD Employee parking:

1. The CBD Employee sticker must be placed on the passenger window, behind the driver.
2. The hangtag must be displayed on the rearview mirror of the vehicle when it is parked.
3. If permit or hangtag is lost, misplaced or stolen, it will not be replaced.
4. CBD Employee Parking is permitted only in parking spaces indicated for CBD Employee
5. CBD Parking located at:
 - **North Walnut Street Lot** - CBD designated spaces (**mobile app** or **hangtag only**)
 - **Hudson Street Garage** @ 25 Hudson Street - **4th level only** (**mobile app**, **kiosk** or **hangtag**)
 - **Cottage Place Lot** - any space (**mobile app**, **kiosk** or **hangtag**)
6. There shall be no CBD Employee parking in the parking spaces indicated for shoppers or diners.
7. Parking shall be permitted from 6:00 a.m. to 2:00 a.m. the following day, seven days per week.
8. No parking shall be permitted between the hours of 2:00 a.m. and 6:00 a.m.
9. Any vehicle parked or remaining at the location in violation of the ordinance shall be subject to a fine of \$165.00 per vehicle, per day.

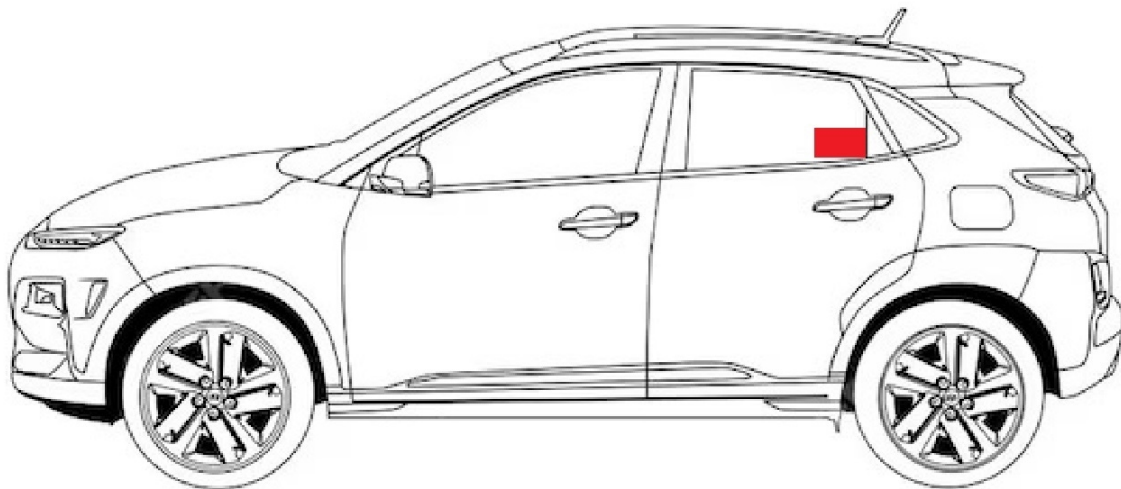
