

Ridgewood Stigma-Free Committee Meeting Minutes 8.19.25

Item 1: Welcome

 Danielle asked the group to introduce themselves because there were a couple of new faces on the call today, such as Michelle Fenwick and Jen Perry, who later joined. Michelle and Jen are from Ridgewood Public Schools. Michelle is the Assistant Superintendent for RPS of Elementary and Special Programs and Jen is the Director of School Counseling K-12.

Item 2: Guest Speaker: Cynthia Chazen, Stigma Ambassador of NJ Governor's Council on Mental Health Stigma

- Cynthia is the Coordinator of Community Outreach and Partnerships for the council. She shared that she's been part of the Stigma-Free Zone since 2012. She worked with Mary Ann Uzzi when Stigma-Free first began in Paramus. She is also Demarest's Stigma-Free Ambassador. Cynthia shared that her experiences have led her to where she is today with the council. The council was created in 2005 to fight stigma in NJ. This year is the 20th year celebration. Cynthia shared that you have to be appointed by the NJ Governor and approved by the Senate in order to be part of this council. Cynthia shared that there are currently seats available to be part of the council, but it's been challenging to get people appointed due to the state. To get around this, Cynthia works with subcommittees to help with initiatives.
- The council is under the New Jersey Association of Mental Health and Addiction Agencies (NJAMHAA). The mission of the New Jersey Governor's Council on Mental Health Stigma is to combat mental health stigma as a top priority in New Jersey's effort to create a better mental health system. Through outreach and education, the council sends a message that mental health stigma must no longer be tolerated. The council currently consists of about 6 members at the moment, all volunteers, unpaid. They are not tasked with addictions. They are always actively looking for people to join the subcommittee. The subcommittee consists of a variety of professionals with different backgrounds.
- The council is currently focused on various initiatives. This includes providing education and support for individuals with intellectual/developmental disabilities. They also want to increase services and outreach efforts to underserved communities. They also want to develop a closer relationship with faith-based groups, for they recognize when people are

- in crisis, they turn to these groups.
- Cynthia discussed a relatively new initiative, Sing! for Mental Health Project. Cynthia said she would share the flyer with Danielle. Basically, it involves adults creating videos to educate the public about stigma. The videos are diverse. They can include art, music, and dance. Only for those 18 and older.
- Gabrielle Milani from the Lukin Center was interested to learn more from Cynthia for she has experience in art and movement therapy.
- Michelle Fenwick was also intrigued by this for the RPS students aged 18-21, who are part of the STEPSS program.
- Cynthia shared that we can contact her anytime. She will share her contact information with Danielle to share with the group.

 Danielle acknowledged that this lifeline had been officially terminated. Danielle wanted to make note that in NJ, there are various agencies that are still able to provide support to the LGBTQ+ community. These include Garden State Equality and Pride Center of NJ. There's also The Trevor Project.
